

In the name of God Amen I william Bunce of the lyes in the parish of **Alborne** in the County of Wilts Yeoman being aged and weak in Body, but of a Sound and perfect mind and memory praise be therefore given to Almighty God for the Same do make and ordaince this to be my present Last will and Testament. in manner in manner following (that is to say) first and principally I recommend my Soul into the hands of Almighty God that gave it hoping through the merritts death and passion of his Sonne Jesus Christ my only Saviour and redeemer, to have full and free pardon and forgiveness of all my Sinnes and thereby to in herritt everlastinh life and my Body I committ to the earth to be decently Buried at the direction of my Executor herein after named, and as touching the disposition of All Such Temporall Estate as it hath pleased Almighty God to bestow upon me I give devise bequeathe and dispose thereof in mannor following **Imprimis** I will that all my Lawfull and just debts and funeral expences be first paid and discharged **Item** I give unto my Sonne **William** Twenty pounds of good and lawfull money of great Brittain to be paid him by my executors herein after mentioned within Two years next after my decease **Item** I give unto my sonne **John** Twenty Pounds of like money to be paid him within Three Years next after my Decease. **Item** I give unto my Daughter **Margarett** Forty Pounds to be paid unto her by my Executors in Such parts and on Such days and times as is hereinafter mencioned (that is to say) Eight and Twenty Pounds of lawfull money at or upon the nine and Twentieth day of September next ensuing the date hereof and Twelve pounds of like money at or upon the fifth day of November then next following, But if my Executors do and shall pay the summe of Eight and Twenty pounds which I am engaged to pay unto **Nicholas Dinner** of **Ogbourne St George** in the County of Wilts aforesaid wheelwright for a house I Bought of him for my said Daughter **Margaret** Then and in such case my said Daughter shall have nore more than The said Twelve pounds to be paid her at the time aforesaid over and beside the said house I bought for her of the said **Nicholas Dinner**. All rest and residue of my personall Estate goods Chattells ready money Debts to me oweing and all the other things whatsoever not herein before given and bequeathed I do hereby devise and bequeathe unto **Margarett** my Dear and Loveing Wife and to my Sonne **Thomas** whome I do hereby make full and sole Executor Joyally of this my last will and Testament revokeing Disannulling and making void all former and other wills by me heretofore made and do declare this to be my present last will and Testament In Witness whereof I have to this my present last will and Testament sett my hand and Seal the Third day of August in the Seaventh year of the reigne of our Sovereigne Lord George by the grace of God of great Brittain France and Ireland King Defender of the Faith &c
