Reverend and Worshipful **William Macdonald**, Clerk, Master of Arts, Archdeacon of the Archdeaconry of Wilts, And by him Administration of all singular the Goods and Chattels of the said Deceased, and any ways concerning his Will was committed unto

**Thomas Butler** one of the joint Executors named in the said Will the like power being reserved to **James Butler** the other Executor also named therein

(being first duly Sworn of the Truth of the said Will, and faithfully to perform the same, and to pay the Deceased's Debts and Legacies as far forth as his Goods and Chattels will thereto extend and the Law bind him, and to exhibit a true and perfect Inventory of the Goods, Chattels, and Credits of the Deceased, and yield a just and true Accompt when lawfully required) saving the Rights of all Persons

This is a Codicil to be added to and taken as part of the last Will and Testament of me **George Butler** of Lains Farm in the Parish of **Aldbourn** in the County of Wilts Yeoman which beares date on the ninth day of February instant

Whereas I have in and by my said will given and bequeathed unto my Daughter **Sarah** the Wife of **James Cook** a Legacy of Three hundred Pounds payable at a future Day Now I do hereby direct and declare that in case she should die leaving lawfull Issue before such Legacy should become payable – the child or children of my said Daughter shall stand in loco parentis and be entitle to such legacy in the same manner as he she or they would have been entitled to the same, if originally named a Legatee or legatees in this my will. I give and bequeath unto my daughter **Martha Castle** a Legacy of Ten Pounds to buy her Mo?? And in all other respects I conform my said will In Witness whereof I have hereunto set my Hand and seal this eleventh day of February 1834.

This is the last Will and Testament of me **George Butler** of Lains Farm in the Parish of **Aldbourn** in the County of Wilts Yeoman Whereby I give and bequeath unto my Wife **Mary Butler** one annuity or yearly Sum of Twenty Pounds to be secured to her by the joint bond of my Sons **Thomas** and **James Butler** and payable by them to her in qual Moieties for and during the term of her natural life, unless they should think proper to purchase her an annuity of the same amount or invest a sufficient Sum of money in the Government Funds to produce the same out of my Persdonal Estate hereinafter bequeathed to them I give and bequeath unto my sones **George** and **William** a legacy of Ten Pounds each to buy them mourning. I give and bequeath unto my Daughter **Sarah** the wife of **James Cook** a legacy of Three hundred Pounds to be paid and payable to her on the feast day of May one thousand eight hundred and thirty seven, without any Interest theron in the mean time. I give and bequeath unto my Grand-daughter **Mary**, the daughter of **George** and **Martha Castle** a legacy of Ninty Pounds to be paid and payable to her on her attaining the sage of Twenty one years. I give and bequeath unto my Son **Thomas Butler** All my Household Furniture and Effects and Household Stores of wey[whatever] sort and kind absolutely – And as to all and singular my Farming Stock crops and Effeccts and all other mt Personal Estate of every sort and kind not hereinbefore otherwise disposed of, I give and bequeath the same and every part therof unto my Sons **Thomas** and **James Butler** To hold to their Executors Administrators and Assigns as Tenants in Common, but I expressly direct and declare that my said Son **James** shall pay or allowout of his share thereof unto my said Son **Thomas** the Sum of Three hundred and thirty five Pounds which I have heretofore advanced and lent to him my said Son **James**. And lastly I hereby appoint my Sones **Thomas Butler** and **James Butler** joint Executors of this my Will. In Witness whereof I have hereunto set and subscribed my hand and Seal this ninth day of February one thousand eight hundred and thirty seven
