The Six and twentieth day of January in the therd year of the Raingne of our Sovereign Lady Ann the first by the grace of god of England Scotland France and Ireland Queen Defender of the faithe Annoqr: Dom. 1704/5.

I **Samuel Castell** Allius **williams** of **Alborn** in the County of Wilts Carpenter Being Aged and weake in body but of A Sound And perfect mind And memory Priase be thearefore Given to god do make And ordaine this my last will And testament In maner And forme following that is to say first And principally I Commend my Soule into the Hands of my saviour Jesus Christ to have full And free Pardon And foregiuiness of All my sins and to inheritt Everlasting life And my body I Committ to the Earth to be decently Buryed At the Discretion of my Exsecutoris Herafter Named And As touching the disposition of All Such temporalls As it Hath pleased Almighty God to bestow upon me I giue And dwise [sic] & dispose therof As followeth. Imprimus I will that All my Debts And funerall charges shall be paid And discharged. Item I giue unto my Son in law **Roger Dennis** Sen<sup>r</sup> one Shilling Item I giue And Devise unto my daughter **Margeret Dennis** twenty=pounds Item I giue And devise unto my granddaughter **Elizabeth** All that I haue or shall haue in the world Both Bills Bonds Mortgages money And every thing that is mine I do hearby giue unto her my s<sup>d</sup> granddaughter Item I giue And devise unto my granson **Roger Dennis** ten pounds Item I giue And devise unto my granddaughter **Myriam Denis** twenty pounds of lawfull English mony All and Every perticuler Sume or sums to be paid whithin 1 week At the end of twelve months next after my decease After the mortgage (which I have upon **William Webb** Alius **Suerut** his Land) shall be paid And discharged All the Reast of goods And Chattels whatsoever not herin before Bequeathed I giue And bequeath unto my Granduaghter Elizabeth whom I do hearby make full And Sole Exsecutoris of this my last will And Testement And I do Hearby revoake disanull And make voide All former And other wills By me heartofore made And do daclare this to be my last will And Testement In Wittnesse whearof I haue to this my Last will And testament Set my hand And Seale the Day And year first Aboue written.
