

In the Name of God Amen I **John Rudler** of the Parish of **Alborn** in th County of Wilts Shopkeeper being sick and weak of body but of sound and perfect Mind and Memory Priase be therefore given to Almighty God do make and ordain this my last Will and Testament in maner and form following (that is to say) first and principally I commend my Sould into the Hands of Almighty God hoping through the Merits, Death, and Passion of my Saviour Jesus Christ to have full and free Pardon and forgiveness of all my sins and to inherit everlastin Life and my body I commit to the Earth to be decently buried at the discretion of my Executrix hereafter named **And** as touching the disposition of all such Temporall Estate it hath pleased Almighty God to bestow upon me, I gige and dispose thereof as fooloweth **First** I will that my Debts and Funeral Charges shall be paid and discharged ~~and~~ **Item** I give unto my Mother **Ann Rudler** the some of one shilling. **Item** I give unto my Brother **George Rudler** the some of one shilling **Item** I give unto my Brother **Richard Rudler** the some of one shilling **Item** I give unto my Brother **Christopher Rudler** the some of one shilling **Item** I give unto my Brother **Henry Rudler** the some of one shilling . **Item** I give unto my Brother **William Rudler** the some of one shilling. **Item** I give unto my Brother **Charls Rudler** the some of one shilling **Item** I give unto my Brother **Thomas Rudler** the some of one shilling **Item** I give unto my sister **Ann Rudler** the some of one shilling **All** the rest and residue of my Parsonall estate Goods and Chattels to gather with all my Roiall Estate Lands and houses in fee to gather with all and singuler my Royal and Parsonall estate whatsoever I shall die posessed of I give and bequeath the same to my welbeloued Wife **Mary Rudler** whome I do hereby appoint full and sole Executrix of this my last will and testament **And** I do hereby revoke disannil and make void all former Wills and Testements by me heretofore made In witnss whereof I the said **John Rudler** have to this my last Will and Testament set my Hand and seal this twentiseventh day of December in the Tenth year of the Reign of our sovereign Lord George the second by the Grace of God of Grate Britain (&c) King Defender of the Faith and in the year of our Lord Christ One thousand seven hundred Thirty and Six
