First, I will y^t my Debts, & funeral Charges, shall be paid, and discharged.

Item I give unto my father, & unto my Mother in law, and unto my three Brothers, that my father had bye her, which is his now, wife, by name, **John, Hinry, & Stephen**, each of y^m Twelue peece a peece, to be paid within one yeare after my desease by my Executor here after named,

Item I doe give unto my Brother **W^m Collins**, And to his wife **Jone**, and to his son **W^m Collins**, & unto his Daghter **Jone Collins**, each of them Twelue pence apeece to be paid by my Executor here after named, within one yeare after my desease

Item I doe give my sister **Nim Adams**, and to her Husband **Stephen Adams** and unto all theire Children, amles, or females, each of them Twelue pence apeece to paid within one yeare after ny desease, by my Executor here in after named,

Item all y^e rest of my Goods and Chattels; and personall Estate whatsoever, I doe give and bequeath unto my Loveing Wife Martha, Her Heirs, and Assigns for ever. Upon Condition she shall pay all my Debts, and Legacies I make her sole Executrix of this my Last Will and Testament revoking oll other Wills and Testaments whatsoever, made by me formerly In Witnes whereof I have here unto sett my Hand and Seale the Twenty fift day of August, In the yeare of our Lord God, one Thousand six hundred Ninety and one.
