Item all the rest of my goods and chattils both moueable and unmoueable I giue and bequeath unto my wife **Susanna Hiatt** whome I make my whole executrix of this my last will and testament In witnesse wherof I haue put to my hand in the day and yeare first aboue writen.

Ittem I constitute and appointe my welbeloved sonns in lawe Roger Smith and Thomas Smith Alies Whiller to be oversears of this my last will and testament and I giue unto them for their paines  $xij^d$  a pease
