I **William King** Sen of **Alborne** in the County of Wiltes Teoman being aged and weake in Body; but of sound and perfect Mind and Memory Praise be therefore given to Almighty God, Doe make and ordaine this my Present Last Will and Testament, in manner and forme following (That is to say) First and Principally I commend my Soul into the Hands of Almighty God, hoping through the Merits, Death, and Passion, of my Saviour Jesus Christ, to have full and free Pardon and Forgivness of all my Sins, and to inherit everlasting Life; and my Body I committ to the Earth, to be decently buried at the discretion of my Executrix hereafter=named And as touching the disposition of all such Temporal Estate, as it hath pleased Almighty God to bestow upon me I give and dispose thereof, as followeth.

Imp<sup>r</sup>ms I will That my Debts and Funeral Charges shall be paid and discharged. Item I give unto my Daughter **Anne Mott** Five Pounds of good and lawfull money of England. Item I give unto my Grandaughter **Rachel Adams** Five Pounds of like lawfull money of England. Item I give unto all the rest of my Daughter **Anne Motts** Children Five shillings apeece. Item I will that My greatest Chest and greastest Salting Trough now standing in My Dwelling:house shall be, and become, standing, abiding; and immoveable Goods, Allwayes to stand, abide and unremoved from My said house from henceforth and for ever.

All the rest and reidue of my Personal Estate, Goods, and Chattels whatsoever, I doe give and bequeath unto my loving Son **William King**; full and whole Executor of this my last Will and Testament. And I desire That my Body may be buried in the Churchyard. And I doe hereby revoke disanul and make void all former Wills and Testaments by me heretofore made In **Witness** whereof I the said **William King** to this my last Will and Testament doe sett my hand and Seal the Nine and Twentyeth Day of March in the Fourth year of the Raigne of o<sup>r</sup> souveraigne Lord James the second by the Grace of God of England Scotland France and Ireland King Defender of the Faith &c Annoq<sup>r</sup> Domini 1688.
