The Will of Thomas Nackstone [sic] deced

This Will was proved at Marlboro^h On the 27th day of April 1754 before the Reverend Abraham Me Maine Doctor in Divinity lawful Surrogate of the Rev^d and Worshipful Henry Stebbing Doctor in Divinity Archdeacon of the Archdeaconry of Wilts and by him Adstration of the Effects of the deced was committed unto Mary Nackstone Widow & Relict of the said Deced and Sole Extrix therein named being first duly Sworn of the truth of the said Will to fulfill the same and to pay the deced debts and legacies as far as the goods and Chattles will extend and to exhibit a true Inventory and Yield a Just Accompt saving the rights of all persons/.

In the name of god Amen I **Thomas Knacstone** of **Albowrn** husbandman in the County ogg Wilts Considering the uncertainty of his mortal like and being of a sound mind and memory Blessed be Almighty god for the same Do make Publish and Declare this my Last will or Testament hereby revoking and Disannuling all former wills by me ever heretofore made First I Committ my soul into the hands of almighty god and my Body to the Earth to be decently Buried at the Discretion of my Executrix herein after named and as to my worldly affairs in the which it hath Pleased god to Bless me with in this life I give and bequeath the same in manner and form following (that is to say) first my will is that all such which I owe in wright and Conscience to any person or persons whatsoever be fully satisfied and paid by my Executrix hereafter named within Convenient time next after my Deseased First I give & bequeath to my Brother **William Knacstone** one shilling in money to be paid at the end of twelve months time next after my Desease And lastly as to all the Rest Residue and remainder of all and singular my goods Chattles Personal Estate Bills bonds writings securities and specialties of what kind nature or sort soever I herby give and bequeath the same to **Mary** my Loving wife Dureing her naturall life and that which remain after he Desease to be for the use of **Georg Smith** my kinsman to him and his heirs Executors or Administrators for ever and I do hereby Ordaine nominate and appoint the said **Mary** my loving wife sole Executrix of this my last will or Testament In wittness whereof I have hereinto have sett my hand and seal the twenty seventh day of march in the twenty sixth year of the Reign of our Sovereign Lord Georg the second by the grace of god of great Brittain France and Ireland king Defender of the Faith And in the year of our lord one thousand seven hundred and Fifty four
